It was held in Lisbon the LSA Global Meeting 2022, over the thematic of “Rage, Reckoning and Remedy”.

Professor Margarida Salema d’ Oliveira Martins, Coordinator of the project “An Ethical Culture of Anti-Corruption: Law, Dialogue, Action, and Education” from CEJEA – Centre for Legal, Economic and Environmental Studies of Lusíada University, and responsible for the research line, Transnational Public Law, submitted a proposal for a panel, which was accepted. The panel was titled “Power, Alienation, and Human Rights”.

Considering the overall topic, the panel called for papers that could address socio-legal contributions integrating, analysing and addressing human rights issues related to contemporary challenges to human rights. In particular, the discussion of complex issues that arise from biotechnologies, genetic selection, Assisted Reproductive Technologies, AI tools; the impact the COVID pandemic. On another perspective, corruption lays at risk the normal functioning of democratic
